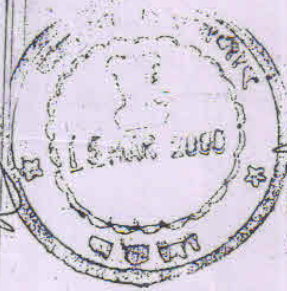

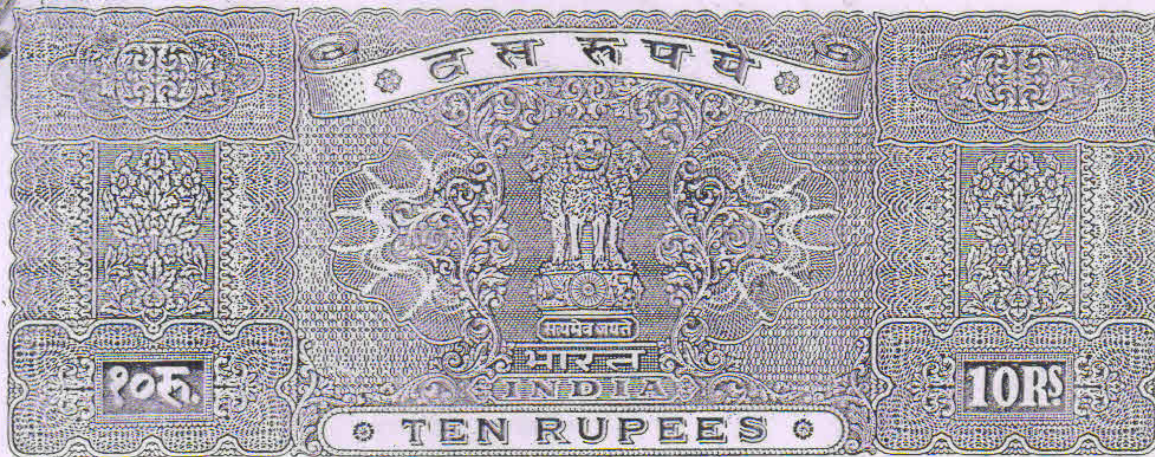

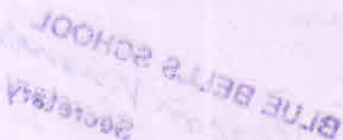

(1) To do any other act for the advancement or general public utility not involving the carrying on or the activity for profit without distinction or caste, colour or creed.

4.
